**Youth Rowing Camps:** For students entering 7<sup>th</sup>- 9<sup>th</sup> grades.

**High School Camps:** For students entering 10<sup>th</sup> – 12<sup>th</sup> grades.

- Camps will continue to teach the fundamentals of rowing
- Camps will run Monday-Friday for two weeks for a total of 20 instruction hours
- Camp fee of \$130 includes: Technical instruction on rowing machines and water; more emphasis on boat speed and racing, a camp T-shirt; Regatta and a picnic on the last day.
- All rowing boats will be accompanied by a motor launch with WBC-approved coaches, and experienced rowers will join the campers in each boat.
